## New Illinois Wesleyan Trustees Named and Officers Elected

BLOOMINGTON, Ill.— At Illinois Wesleyan University's final 2013-14 Board of Trustees meeting on May 16, three new members were named and the current officers were re-elected to serve for the coming 2014-15 academic year.

Of the 42 Board members, 10 current members were re-elected, and two new trustees and one new Alumni Association Trustee representative were named. Following are the three new Board members.

**Mark W. Ohlendorf** of Milwaukee received a bachelor of arts degree in political science from Illinois Wesleyan in 1982. He has over 25 years of experience in the health care and long-term care industries and currently serves as co-president and chief financial officer of Brookdale Senior Living, the nation's largest owner and operator of senior living communities throughout the United States and a leading national provider of senior-related services.
