Jack Horenberger, who will retire as athletic director and baseball coach at Illinois Wesleyan University Aug. 1, was awarded the rank of Athletic Director Emeritus by the IWU board of trustees at its business meeting Tuesday.

Horenberger, a 1936 graduate of Wesleyan and a member of the coaching staff since 1942, has been the university's athletic director since 1947. He has a master's degree from the University of Illinois.

Two faculty members were granted tenure, 15 were promoted in rank and nine were given leaves of various types and lengths for the 1981-82 school year. All promotions are effective with the 1981-82 fiscal year, which begins Aug. 1.

Granted tenure were Dr. Jonathon P. Dey, biology, and Robert W. Frizzell, library.

Dr. Carole A. Brandt, director of the School of Drama, and Dr. John D. Heyl, chairman of the department of history, were promoted from associate professor to full professor, the highest rank for active faculty members.

Advanced from assistant professor to associate professor were Miles C. Bair, director of the School of Art; Barbara A. Biehler, nursing; Dr. Carl B. Jensen, psychology; Dr. Ronald D. Sandstrom, mathematics; Sammy G. Scifres, music; and M. Anne Woodtli, nursing.

Promotions from instructor to assistant professor were given to Kathleen A. Baldwin, nursing; Barbara A. Cothren, women's physical education; Dr. Timothy J. Garvey, art; Dr. Michael W. Johnson, political science; Kevin J. Strandberg, art; Dr. Louis Verner, biology; and Dr. Deborah A. Wilder, chemistry.

Fred B. Brian, art, and Dr. Sue A. Huseman, chairman of the department of foreign languages, were granted sabbatical leaves for the 1981-82 school year and Dey was given a sabbatical for the 1982 calendar year.

Dr. Forrest J. Frank, chemistry, was given sabbatical for the first semester of 1981-82 and sabbaticals for the spring term were awarded to Dr. Robert P. Donalson and Dr. Thomas W. Streeter, both music, and Alice R. Swift, nursing.

C. William Cummings, business administration, was granted an educational leave for the full school year, and Dr. Bonnie A. Beckett, foreign languages, was given leave without pay for the full year.
